Minutes of the monthly meeting held on Monday 10 April 2006 At the Village Hall, Walton at 7.30 p.m.

1. Apologies for Absence

2. Declaration of Interests

There were no interests to be declared.

3. Minutes of the Previous Meeting

The Minutes of the previous Meeting, held on 13 March 2006, having been previously circulated, were approved and signed.

4. Matters Arising

a). Police Matters

P.C. Booth informed the meeting that there had been no reported crimes in March compared to 5 for the same period last year.

b) Bus Shelter Update

The Ward Councillors had deferred a decision for funding towards the bus shelter. They had extended an invitation for a councillor to attend their next meeting on 9 May to put forward a case for providing a shelter. Councillor Fothergill would attend on behalf of the council.

c) Charity of the Unknown Donor

There were no further developments on this matter.

d) Springs Lane Update

An email had been received from Ian Haigh, LCC Highways Department confirming; RMS will introduce signing on the A1 southbound carriageway advising traffic bound for Thorp Arch Trading Estate to leave the A1 at the Walton Road junction, North Yorkshire will introduce a sign on B1224 York Road advising westbound traffic bound for Thorp Arch Trading Estate to use Rudgate, City Services are promoting signing on Wetherby Road indicating that the route to the A1 via Springs Lane is unsuitable for HGVs and advising HGVs to go via Walton Road and that City Services are promoting a 30mph speed limit on Wetherby Road in the vicinity of Walton village.

The signs on Wetherby Road had already been fitted and it was agreed that they seemed to be having some positive effect on traffic through the village. The 30mph signs were expected soon. A date for fitting the York Road signs would be sought from North Yorkshire County Council.

Mr Haigh attached a summary of automatic traffic counts carried out in September 2005, an automatic speed survey carried out in December 2005 and a summary of a manual classified count at the Springs Lane/Main Street junction carried out in December 2005 for information and confirmed that he will be carrying out further ATC surveys during April/May on Springs Lane, Rudgate and Wetherby Road.
